ORDER:

The Social Welfare Department have informed that the Member Secretary, Curukulam, A.P., Hyderabad in the reference 1st read above has stated that there is urgent need to establish one Residential School for Girls at Rayachoti in Kadapa District as there is no Tribal Welfare Residential School at Rayachoti to cater the educational needs of S.T. population in Kadapa District. He has requested to consider for sanction of one Tribal Welfare Residential School for Girls at Rayachoti, Kadapa District with non-recurring expenditure of Rs. 141.58 lakhs per annum and recurring expenditure of Rs. 144.51 lakhs per annum with the following supporting staff:

The posts of Principal and Senior Assistant shall be filled up on regular basis and the posts of PGT, PET and Art/Craft/Music Teacher shall be filled up by Contract Residential Teachers. The remaining services i.e. one staff Nurse, two Attenders, Two Cooks, three MPWs and one Kitchen helper shall be outsourced duly following guidelines on out-sourcing.
