Girls of Tanakal and its contiguous mandals. Hence there is urgent need to establish Tribal Welfare Residential School for Girls at Tanakal. Therefore the Director, Tribal Welfare, has requested for starting of Tribal Welfare Residential School for Girls at Tanakal, Ananthapur District with the following Teaching and Non-teaching staff with non-recurring expenditure (1st year) of Rs. 119.97 lakhs, recurring expenditure (1st year) of Rs. 31.20 lakhs and other charges Rs. 10.01 lakhs.
